

RULES

Australian Huntington's Disease Association (Qld) Inc Trading as Huntingtons Queensland



NAME

1. The Name of the incorporated Association shall be "AUSTRALIAN HUNTINGTON'S DISEASE ASSOCIATION (QLD) INC."

OBJECTS

- 2. The Associations object is to enable those impacted by Huntington's disease to live their best lives by means which include, but are not limited to:
 - 2.1. Promoting the prevention and control of Huntington's disease
 - 2.2. Offering support for families and dependants of sufferers of the disease.
 - 2.3. Facilitating the provision of suitable professional help and advice:
 - 2.3.1. For those at risk with the disease, and
 - 2.3.2. For non-professional people having the responsibility for caring for and making decisions affecting sufferers from the disease.
 - 2.4. Improving the community's awareness of the disease, and its effect on sufferers, their dependants and the community, and its awareness of the need and moral obligation to provide more adequate help for sufferers and their dependants.
 - 2.5. Promoting a better understanding by the medical profession of the signs and symptoms, occurrence and control of the disease.
 - 2.6. Giving families of sufferers a strong single voice when making representations to governmental and other bodies.
 - 2.7. Maintaining the right to anonymity of the Association's membership.
 - 2.8. Raising funds for use by the Association in the pursuit of its objectives.
 - 2.9 Doing any other appropriate things to help those affected in any way by the disease.

POWERS

- 3. The powers of the Association are:
 - 3.1. To take over the funds and other assets and the liabilities of the present unincorporated association known as the Australian Huntington's Disease Association (Qld);
 - 3.2. To subscribe to, become a member of and co-operate with any other association, club or organisation, whether incorporated or not, whose objects are altogether or in part similar to those of the Association provided that the Association shall not subscribe to or support with its funds any club, association or organisation which does not prohibit the distribution of its income and property among its members to an extent at least as great as that imposed on the Association under of by virtue of rule 28.10;



- 3.3. In furtherance of the objects of the Association to buy, sell and deal in all kinds of articles, commodities and provision both liquid and solid, for the members of the Association or persons frequenting the Association's premises;
- 3.4. To purchase, take on lease or in exchange, hire and otherwise acquire any lands, buildings, easements or property, real and personal, and any rights or privileges which may be requisite for the purposes of, or capable of being conveniently used in connection with any of the objects of the Association; provided that in case the Association shall take or hold any property which may be subject to any trusts the Association shall only deal with the same in such manner as is allowed by law having regard to such trusts;
- 3.5. To enter into any arrangement with any Government or Authority that are incidental or conducive to the attainment of the objects and the exercise of the powers of the Association; to obtain from any such Government or authority any rights, privileges and concessions which the Association may think it desirable to obtain; and to carry out, exercise and comply with any such arrangements, rights, privileges and concessions.
- 3.6. To appoint, employ, remove or suspend such managers, clerks, secretaries, servants, workmen and other persons as may be necessary or convenient for the purpose of the Association.
- 3.7. To remunerate any person or body corporate for services rendered, or to be rendered, and whether by way of brokerage or otherwise in placing or assisting to place or guaranteeing the placing or any unsecured notes, debentures or other securities of the incorporated association, or in or about the incorporated association or promotion of the incorporated association or in the furtherance of its objects;
- 3.8. To consist, improve, maintain, develop, work, manage, carry out, alter or control any houses, buildings, grounds, works or conveniences which may seem calculated directly or indirectly to advance the Association's interests, and to contribute to subsidise or otherwise assist and take part in the construction, improvement, maintenance, development, working, management, carrying out, alteration or control thereof;
- 3.9. To invest and deal with the money of the Association not immediately required in such manner as may from time to time be thought fit; subject where application to Regulation 32(14) of the Collections Regulations 1975;
- 3.10. To take, or otherwise acquire, and hold shares, debentures or other securities of any company or body corporate;
- 3.11. In furtherance of the objects of the Association to lend and advance money or give credit to any person or body corporate; to guarantee and give guarantees of indemnities for the payment of money for the performance of contracts or



- obligations by any person or body corporate, and otherwise to assist any person or body corporate;
- 3.12. To borrow or raise money either alone or jointly with any other person or legal entity in such manner as may be thought proper and whether upon fluctuating advance account or overdraft or otherwise to represent or secure any moneys and further advances borrowed or to be borrowed alone of with others as aforesaid by notes secured or unsecured, debentures or debenture stock perpetual or otherwise, or by mortgage, charge, lien or other security upon the whole or any part of the incorporated association's property or assets present or future and to purchase, redeem or pay-off any such securities;
- 3.13. To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading and other negotiable or transferrable instruments:
- 3.14. In furtherance of the objects of the Association to sell, improve, manage, develop, exchange, lease, dispose of, turn to account or otherwise deal with all or any part of the property and rights of the Association;
- 3.15. To take or hold mortgages, liens or charges, to secure payment of the purchase price, or any unpaid balance of the purchase price, of any part of the Association's property of whatsoever kind sold by the Association, or any money due to the Association from purchasers and others;
- 3.16. To take any gift of property whether subject to any special trust or not, for any one or more of the objects of the Association but subject always to the proviso in sub-rule 3.4;
- 3.17. To take such steps by personal or written appeals, public meetings or otherwise, as may from time to time be deemed expedient for the purpose of procuring contributions to the funds of the Association, in the shape of donations, annual subscriptions or otherwise;
- 3.18. To print and publish any newspapers, periodicals, books or leaflets that the Association may think desirable for the promotion of its objects;
- 3.19. In furtherance of the objects of the Association to amalgamate with any one or more incorporated associations having objects altogether of in part similar to those of the Association and which shall prohibit the distribution of its or their income and property among its or their members to an extent at least as great as that imposed upon the Association under of by virtue of rule 28.10; provided that such incorporated association or associations satisfy the requirements of Section 78 (1)(a) of the Income Tax Assessment Act;
- 3.20. In furtherance of the objects of the Association to purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagements of any one or more of the incorporated associations with which the Association is authorised to amalgamate;



- 3.21. In furtherance of the objects of the Association to transfer all or any part of the property, assets, liabilities and engagements of the Association to:
 - 3.21.1. Any one or more of the incorporated associations with which the Association is authorised to amalgamate; or
 - 3.21.2. Another entity with the object of promoting the prevention and control of the disease;
- 3.22. To make donations for patriotic, charitable or community purposes.
- 3.23. To transact any lawful business in aid of the Commonwealth of Australia in the prosecution of any war in which the Commonwealth of Australia is engaged;
- 3.24. To do all such other things as are incidental or conducive to the attainment of the objects and the exercise of the powers of the Association.

CLASS OF MEMBERS

- 4.1. The membership of the Association shall consist of ordinary members, and any of the following classes of members:
 - 4.1.1. Associate members;
 - 4.1.2. Life members;
 - 4.1.3. Honorary members;
- 4.2. The number of ordinary members shall be unlimited. Any adult person interested in furthering the Objectives of the Association as defined above shall be eligible for ordinary membership.
- 4.3. The number of associate members shall be unlimited. Any person who is employed as a professional in the care of Huntington's Disease sufferers and wishes to receive information about the disease from the Association shall be eligible for associate membership.
- 4.4. The number of life members shall be unlimited. Any person who, in the opinion of the Management Committee, has demonstrated involvement in and support for the Association's work consistently over an extended period shall be eligible for consideration for life membership.
- 4.5. The number of honorary members shall be limited. Any person who has provided outstanding assistance to the Association or Huntington's Disease sufferers shall be eligible for consideration for honorary membership.
- 4.6. A financial member at any material time is a member who is not then indebted to the organisation in respect of annual subscription or levy or other payment whatsoever.
- 4.7. Only those members who are financial members at the time shall be entitled, subject to the lawful procedure of the meeting, to speak or vote upon any motion at any general meeting of the organisation.

MEMBERSHIP



- 5.1. Every person who at the date of incorporation of the Association (10th August 1988) was a member of the Australian Huntington's Disease Association (Qld) and who on or before the date of incorporation agrees in writing to become a member of the Association shall be admitted by the Management Committee to the same class of membership of the Association as that member held in the unincorporated association. Every member of the Association who previously to his agreeing to become a member of the Association has paid his subscription due on the First day of April 1988, as a member of the Australian Huntington's Disease Association (Qld), shall not be liable to pay any further sum by way of annual subscription to the Association for the period prior to the First day of April 1989.
- 5.2. Every applicant for any class of membership of the Association (other than the members of the unincorporated association referred to in sub-rule 5.1) shall be made in writing, signed by the applicant, and shall be in such form as the Management Committee from time to time prescribes.

MEMBERSHIP FEES

- 6.1. The membership fees for each class of membership shall be such sum as the members shall from time to time at any general meeting so determine.
- 6.2. The membership fees for each class of membership shall be payable at such time and in such manner as the Management Committee shall from time to time determine.

ADMISSION AND REJECTION OF MEMBERS

- 7.1. At the next meeting of the Management Committee after the receipt of any application and the fee applicable for any class of membership, such application shall be considered by the Management Committee, who shall thereupon determine upon the admission or rejection of the applicant.
- 7.2. Any applicant who receives a majority of the votes of the members of the Management Committee present at the meeting at which such application is being considered, shall be accepted as a member to the class of membership applied for.
- 7.3. Upon either acceptance or rejection of an application for any class of membership, the secretary shall forthwith give the applicant notice in writing of such acceptance or rejection.

TERMINATION OF MEMBERSHIP

8.1. A member may resign from the Association at any time by giving notice in writing to the secretary. Such resignation shall take effect at the time such notice is received by the secretary unless a later date is specified in the notice when it shall take effect on that later date.



8.2. If a member:

- 8.2.1. is convicted of an indictable offence; or
- 8.2.2. fails to comply with any of the provisions of these Rules; or
- 8.2.3. has membership fees in arrears for a period of two months or more; or
- 8.2.4. conducts himself in a manner considered to be injurious or prejudicial to the character or interests of the Association:

the Management Committee shall consider whether his membership shall be terminated.

8.3. The member concerned shall be given a full and fair opportunity of presenting his case and if the Management Committee resolves to terminate his membership it shall instruct the secretary to advise the member in writing accordingly.

APPEAL AGAINST REJECTION OR TERMINATION OF MEMBERSHIP

- 9.1. A person whose application for membership has been rejected or whose membership has been terminated may within one month of receiving written notification thereof, lodge with the secretary written notice of his intention to appeal against the decision of the Management Committee.
- 9.2. Upon receipt of a notification of intention to appeal against rejection or termination of membership the secretary shall convene, within three months of the date of receipt by him of such notice, a general meeting to determine the appeal. At any such meeting the applicant shall be given the opportunity to fully present his case and the Management Committee or those members thereof who rejected the application for membership or terminated the membership subsequently shall likewise have the opportunity of presenting its or their case. The appeal shall be determined by the vote of the members present at such meeting.
- 9.3. Where a person whose application is rejected, does not appeal against the decision of the Management Committee within the time prescribed by these Rules or so appeals but the appeal is unsuccessful, the secretary shall forthwith refund the amount of any fee paid.

REGISTER OF MEMBERS

- 10.1. The Management Committee shall cause a Register to be kept in which shall be entered the names and residential addresses of all persons admitted to membership of the Association and the dates of their admission.
- 10.2. Particulars shall also be entered into the Register of deaths, resignations, terminations and reinstatements of membership and any further particulars as the Management Committee or the members at any general meeting may require from time to time.



10.3. The Register shall be open for inspection at all reasonable times by any member who previously applies to the secretary for such inspection.

MEMBERSHIP OF MANAGEMENT COMMITTEE

- 11.1. The Management Committee of the Association shall consist of a President, Vice-President, Secretary, Treasurer, all of whom shall be members of the Association, and such number of other members as the members of the Association at any general meeting may from time to time elect or appoint.
- 11.2. At the annual general meeting of the Association, all the members of the Management Committee for the time being shall retire from office, but shall be eligible upon nomination for re-election.
- 11.3. The election of officers and other members of the Management Committee shall take place in the following manner:
 - 11.3.1. Any two members of the Association shall be at liberty to nominate any other member to serve as an officer or other member of the Management Committee;
 - 11.3.2. The nomination, which shall be in writing, and signed by the member and his proposer and seconder, shall be lodged with the secretary at least fourteen days before the annual general meeting at which the election is to take place;
 - 11.3.3. A list of the candidates' names in alphabetical order, with the proposers' and seconders' names, shall be posted in a conspicuous place in the office or usual place of meeting of the Association for a least seven days immediately preceding the annual general meeting.
 - 11.3.4. Balloting lists shall be prepared (if necessary) containing the names of the candidates in alphabetical order, and each member present at the annual general meeting shall be entitled to vote for any number of such candidates not exceeding the number of vacancies.
 - 11.3.5. Should, at the commencement of such meeting, there be an insufficient number of candidates nominated, nominations may be taken from the floor of the meeting.
- 12. Any member of the Management Committee may resign from membership of the Management Committee at any time by giving notice in writing to the secretary but such resignation shall take effect at the time such notice is received by the secretary unless a later date is specified in the notice when it shall take effect on that later date or such member may be removed from office at a general meeting of the Association where that member shall be given the opportunity to fully present his case. The question of removal shall be determined by the vote of the members present at such a general meeting.



VACANCIES ON THE MANAGEMENT COMMITTEE

- 13.1. The Management Committee shall have power at any time to appoint any member of the Association to fill any casual vacancy on the Management Committee until the next annual general meeting.
- 13.2. The continuing members of the Management Committee may act notwithstanding any casual vacancy in the Management Committee but if and so long as their number is reduced below the number fixed by or pursuant to these Rules as the necessary quorum of the Management Committee, the continuing member or members may act for the purpose of increasing the number of members of the Management Committee to that number or of summoning a general meeting of the Association, but for no other purpose.

FUNCTIONS OF THE MANAGEMENT COMMITTEE

- 14.1. Except as otherwise provided by these Rules and subject to resolutions of the members of the Association carried at any general meeting the Management Committee:
 - 14.1.1. shall have the general control and management of the administration of the affairs, property and funds of the Association; and
 - 14.1.2. shall have authority to interpret the meaning of these Rules and any matter relating to the Association on which these Rules are silent.
- 14.2. The Management Committee shall exercise all the powers of the Association:
 - 14.2.1. to borrow or raise or secure the payment of money in such manner as the members of the Association may think fit and secure the same or the payment or performance of any debt, liability, contract, guarantee or other engagement incurred or to be entered into by the Association in any way and in particular by the issue of debentures, perpetual or otherwise, charged upon all or any of the Association's property, both present and future, and to purchase, redeem or pay off any such securities:
 - 14.2.2. to borrow money from members at a rate of interest not exceeding interest at the rate for the time being charged by bankers in Brisbane for overdrawn accounts or money lent, whether the term of the loan be short or long, and to mortgage or charge its securities, whether outright or as security for any debt, liability or obligation of the Association, and to provide and pay off any such securities; and
 - 14.2.3. to invest in such manner as the members of the Association may from time to time determine.

MEETINGS OF MANAGEMENT COMMITTEE



- 15.1. The Management Committee shall meet at least once every calendar month to exercise its functions.
- 15.2. A special meeting of the Management Committee shall be convened by the secretary on the requisition in writing signed by not less than one-third of the members of the Management Committee, which requisition shall clearly state the reasons why such special meeting is being convened and the nature of the business to be transacted thereat.
- 15.3. At every meeting of the Management Committee a simple majority by a number equal to the number of members elected and/or appointed to the Management Committee as at the close of the last general meeting of the members, shall constitute a quorum.
- 15.4. Subject as previously in the Rule, the Management Committee may meet together and regulate its proceedings as it thinks fit: provided that questions arising at any meeting of the Management Committee shall be decided by a majority of votes and; in the case of equality of votes, the question shall be deemed to be decided in the negative.
- 15.5. A member of the Management Committee shall not vote in respect of any contract or proposed contract with the Association in which he is interested, or in any matter arising thereout, and if he does so vote his vote shall not be counted.
- 15.6 Not less than fourteen days notice shall be given by the secretary to members of the Management Committee of any special meeting of the Management Committee. Such notice shall clearly state the nature of the business to be discussed thereat.
- 15.7. The President shall preside as Chairman at every meeting of the Management Committee, or if there is no President, or if at any meeting he is not present within ten minutes after the time appointed for holding the meeting, the Vice-President shall be Chairman or the Vice-President is not present at the meeting then the members may choose one of their number to be Chairman of the meeting.
- 15.8. If within half an hour from the time appointed for the commencement of a Management Committee meeting a quorum is not present, the meeting, if convened upon the requisition of members of the Management Committee, shall lapse. In any other case it shall stand adjourned to the same day in the next week at the same time and place, or to such other day and at such other time and place as the Management Committee may determine and if at the adjourned meeting a quorum is not present within half an hour from the time appointed for the meeting, the meeting shall lapse.
- 16.1. The Management Committee may delegate any of its powers to a subcommittee of such members of the Association as the Management Committee



- thinks fit. Any sub-committee so formed shall in the exercise of the powers so delegated conform to any regulations that may be imposed on it by the Management Committee.
- 16.2. A sub-committee may elect a Chairman of its meetings. If no Chairman is elected, or if at any meeting the Chairman is not present within ten minutes after the time appointed for holding the meeting, the members present may choose one of their number to be Chairman of the meeting.
- 16.3. A sub-committee may meet and adjourn as it thinks proper. Questions arising at any meeting shall be determined by a majority of votes of the members present and, in the case of an equality of votes, the question shall be deemed to be decided in the negative.
- 17. All acts done by any meeting of the Management Committee or of a sub-committee or by any person acting as a member of the Management Committee shall, notwithstanding that it is afterwards discovered that there was some defect in the appointment of any such member of the Management Committee or person acting as aforesaid, or that the members of the Management Committee or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a member of the Management Committee.
- 18. A resolution in writing signed by all the members of the Management Committee for the time being entitled to receive notice of a meeting of the Management Committee shall be as valid and effectual as if it has been passed at a meeting of the Management Committee duly convened and held. Any such resolution may consist of several documents in like form, each signed by one or more members of the Management Committee.

ANNUAL GENERAL OR GENERAL MEETINGS

- 19. The first general meeting shall be held at such time, not being less than one month nor more than three months after the incorporation of the Association, and at such place as the Management Committee may determine.
 - 20.1. The annual general meeting shall be held within six months from the close of the financial year.
 - 20.2 The business to be transacted at every annual general meeting shall be:
 - 20.2.1. the receiving of the Management Committee's report and the statement of income and expenditure, assets and liabilities, and mortgages, charges and securities affecting the property of the Association for the preceding financial year;
 - 20.2.2. the receiving of the auditor's report upon the books and accounts for the preceding financial year;
 - 20.2.3. the election of members of the Management Committee; and
 - 20.2.4 the appointment of an auditor.



- 21. The secretary shall convene a special general meeting:
 - 21.1. when directed to do so by the Management Committee; or
 - 21.2. on the requisition in writing signed by not less than one-third of the members presently on the Management Committee or not less than the number of ordinary members of the Association which equals double the number of members presently on the Management Committee plus one. Such requisition shall clearly state the reasons why such special general meeting is being convened and the nature of the business to be transacted thereat; or
 - 21.3. on being given a notice in writing of an intention to appeal against the decision of the Management Committee to reject an application for membership or to terminate the membership of any person.
 - 22.1. At any general meeting the number of members required to constitute a quorum shall be the number of members elected or appointed to the Management Committee plus one.
 - 22.2. No business shall be transacted at any general meeting unless a quorum of members is present at the time when the meeting proceeds to business. For the purposes of the Rule 'member' includes a person attending as a proxy or as representing a corporation which is a member.
 - 22.3. If within half an hour from the time appointed for the commencement of a general meeting a quorum is not present, the meeting, if convened upon the requisition of members of the Management committee or the Association, shall lapse. In any other case it shall stand adjourned to the same day in the next week at the same time and place, or to such other day and at such other time and place as the Management Committee may determine, and if at the adjourned meeting a quorum is not present with half an hour from the time appointed for the meeting, the members present shall be a quorum.
 - 22.4 The Chairman may, with the consent of any meeting at which a quorum is present (and shall if so directed by the meeting), adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from with the adjournment took place. When a meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting. Save as aforesaid it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.
 - 23.1. The secretary shall convene all general meetings of the Association by giving not less than 14 days' notice of any such meeting to the members of the Association.
 - 23.2. The manner by which such notice shall be given shall be determined by the Management Committee; provided that notice of any meeting convened for the



purpose of hearing and determining the appeal of a member against the rejection or termination of his membership by the Management Committee, shall be given in writing. Notice of a general meeting shall clearly state the nature of the business to be discussed thereat.

- 24. Unless otherwise provided by these rules, at every general meeting:
 - 24.1. the President shall preside as Chairman, or if there is no President, or if he is not present with fifteen minutes after the time appointed for the holding of the meeting or is unwilling to act, the Vice-President shall be the Chairman or if the Vice-President is not present or is unwilling to act then the members present shall elect one of their number to be Chairman of the meeting.
 - 24.2. the Chairman shall maintain order and conduct the meeting in a proper and orderly manner;
 - 24.3. every question, matter or resolution shall be decided by a majority of votes of the members present;
 - 24.4. every financial member present shall be entitled to one vote and in the case of an equality of votes, the Chairman shall have a second or casting vote; provided that no member shall be entitled to vote at any general meeting if his annual subscription is in arrears at the date of the meeting;
 - 24.5. voting shall be by show of hands or a division of members, unless not less than one-fifth of the members present demand a ballot, in which event there shall be a secret ballot. The Chairman shall appoint two members to conduct the secret ballot in such manner as he shall determine and the result of the ballot as declared by the Chairman shall be deemed to be the resolution of the meeting at which the ballot was demanded;
 - 24.6 a member may vote in person or by proxy or by attorney and on a show of hands every person present who is a member or a representative of a member shall have one vote and in a secret ballot every member present in person or by a proxy or by attorney or other duly authorised representative shall have one vote;
 - 24.7. the instrument appointing a proxy shall be in writing, in the common or usual form under the hand of the appointor or of the attorney duly authorised in writing or, if the appointor is a corporation, either under seal or under the hand of an officer or attorney duly authorised. A proxy may but need not be a member of the Association. The instrument appointing a proxy shall be deemed to confer authority to demand or join in demanding a secret ballot;
 - 24.8. where it is desired to afford members an opportunity of voting for or against a resolution the instrument appointing a proxy shall be in the following form or a form as near thereto as circumstances permit:

- 24.9. the instrument appointing a proxy shall be deposited with the secretary prior to the commencement of any meeting at which the person named in the instrument proposes to vote; and
- 24.10.the secretary shall cause full and accurate minutes of all questions, matters, resolutions and other proceedings of every Management Committee meeting and general meeting to be entered in a book to be open for inspection at all reasonable times by any financial member who previously applies to the secretary for that inspection. For the purposes of ensuring the accuracy of the recording of such minutes, the minutes of every Management Committee meeting shall be signed by the Chairman of that meeting or the Chairman of the next succeeding Management Committee meeting verifying their accuracy. Similarly, the minutes of every general meeting shall be signed by the Chairman of that meeting or the Chairman of the next succeeding general meeting; provided that the minutes of any annual general meeting shall be signed by the Chairman of that meeting or the Chairman of the next succeeding general meeting or annual general meeting.

BY-LAWS

25. The Management Committee may from time to time make, amend or repeal by-laws, not inconsistent with these Rules, for the internal management of the Association and any by-law may be set aside by a general meeting of members.

ALTERNATION OF RULES

26. Subject to the provisions of the Associations Incorporation Act 1981, these Rules may be amended, rescinded or added to from time to time by a special resolution carried at any general meeting, provided that no such amendment, rescission or addition shall be valid unless the same shall have been previously submitted to and approved by the chief executive currently administering the Act and the minister responsible for the administration of the Collections Act 1966.

COMMON SEAL



27. The Management Committee shall provide for a Common Seal and for its safe custody. The Common Seal shall only be used by the authority of the Management Committee and every instrument to which the Seal is affixed shall be signed by a member of the Management Committee and shall be counter-signed by the secretary or by a second member of the Management Committee or by some other person appointed by the Management Committee for the purpose.

FUNDS AND ACCOUNTS

- 28.1. The funds of the Association shall be banked in the name of the Association in such bank as the Management Committee may from time to time direct.
- 28.2. Proper books and accounts shall be kept and maintained either in written or printed form in the English language showing correctly the financial affairs of the Association and the particulars usually shown in the books of a like nature.
- 28.3. All moneys shall be banked as soon as practicable after receipt thereof.
- 28.4 All amounts of \$100 or more shall be paid by cheque or electronic transfer and must be authorised and/or signed by any two of the president, secretary, treasurer or any other member authorised from time to time by the Management Committee.
- 28.5. Cheques shall be crossed 'not negotiable' except those in payment of wages, allowances or petty cash recoupments which may be open.
- 28.6. The Management Committee shall determine the amount of petty cash which shall be kept on the imprest system.
- 28.7. All expenditure shall be approved or ratified at a Management Committee meeting.
- 28.8. As soon as practicable after the end of each financial year the treasurer shall cause to be prepared a statement containing particulars of:
 - 28.8.1. the income and expenditure for the financial year just ended; and
 - 28.8.2. the assets and liabilities and of all mortgages, charges and securities affecting the property of the Association at the close of that year.
- 28.9 All such statements shall be examined by the auditor who shall present his report upon such audit to the secretary prior to the holding of the annual general meeting next following the financial year in respect of which such audit was made.
- 28.10. The income and property of the Association whencesoever derived shall be used and applied solely in promotion of its objects and in the exercise of its powers as set out herein and no portion thereof shall be distributed, paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit to or amongst the members of the Association provided that nothing herein contained shall prevent the payment in good faith of interest to any such member in respect of moneys advanced by him to the Association or otherwise



owing by the Association to him or of remuneration to any officers or servants of the Association or to any member of the Association provided further that nothing herein contained shall be construed so as to prevent the payment or repayment to any member of out of pocket expenses, money lent, reasonable and proper charges for goods hired by the Association or reasonable and proper rent for premises demised or let to the Association.

DOCUMENTS

29. The Management Committee shall provide for the safe custody of books, documents, instruments of title and securities of the Association.

FINANCIAL YEAR

30. The financial year of the Association shall close on the Thirtieth day of June in each year.

WINDING UP AND REVOCATION OF ENDORSEMENT

- 31.1 If the Association is wound up, any surplus assets must not be distributed to a member or a former member of the Association, unless the member or former member is an entity described in clause 31.2.
- 31.2 Subject to clause 31.4, any other applicable Act and any court order, if any surplus assets remain following the winding up of the Association:
 - (a) the surplus assets must be given or transferred to one or more entities which is registered as a charity under the ACNC Act and which, by its governing document, is:
 - required to pursue charitable purposes which are similar to, or inclusive of, the object of the Association;
 - (ii) required to apply its income and property in promoting its charitable purposes; and
 - (iii) prohibited from making any distribution of surplus assets to its members to at least the same extent as the Association:
 - (b) in addition to the requirements of clause 31.2(a), the surplus assets must be given or transferred:
 - (i) to an institution that may be registered under Part 11A of the TAA;
 - (ii) to an institution the QLD Commissioner is satisfied has a principal object or pursuit that is fulfilling a charitable object or promoting the public good; or
 - (iii) for a purpose the QLD Commissioner is satisfied is charitable or for the promotion of the public good.
- 31.3 The entity or entities to which the surplus assets are to be given or transferred under clause 31.2 must be determined by the members at or before winding



- up and in default, by application to the Supreme Court of Queensland for determination.
- 31.4 Subject to clause 31.5, if the Association is endorsed as a deductible gift recipient under the Tax Act then on the winding up or revocation of endorsement of the Association any surplus of the following assets, namely:
 - (a) gifts of money or property for the object of the Association of the Association:
 - (b) Deductible Contributions received by the Association in relation to a fundraising event held for the object of the Association of the Association;
 - (c) money received by the Association because of such gifts or Deductible Contributions including, without limitation, any money received because of the investment of those gifts or Deductible Contributions.

will, be given or transferred to a fund, authority or institution gifts to which are deductible under Division 30 of the Tax Act and which, by its constitution, is:

- (d) required to pursue charitable purposes which are similar to, or inclusive of, the object of the Association;
- (e) required to apply its income and property in promoting its charitable purposes; and
- (f) prohibited from making any distribution of surplus assets to its members to at least the same extent as the Association,

such fund, authority or institution to be determined by the members, and in default, by application to the Supreme Court of Queensland for determination.

- 31.5 The surplus described in clause 31.4 may only be given or transferred:
- (a) to an institution that may be registered under Part 11A of the TAA;
- (b) to an institution the QLD Commissioner is satisfied has a principal object or pursuit that is fulfilling a charitable object or promoting the public good; or
- (c) for a purpose the QLD Commissioner is satisfied is charitable or for the promotion of the public good.
- For the avoidance of doubt where clause 31.4 applies upon winding up of the Association, any surplus assets other than those listed in clause 31.4 must be distributed in accordance with clause 31.2.
