Dear members and HD community

It's been a historical year for Huntingtons Queensland as we joined 4 other states on agreed integration planning to form our first national body - Huntington's Australia. I am pleased to advise that operational transition was executed on the 1st October 2023 and we continue now in winding up Huntingtons Queensland affairs. A key final step for us will be proposing a motion at the AGM on 30th November 2023 to legally wind-up Huntingtons Queensland.

I am pleased to provide an update on the operational developments within Huntington's Queensland (HQ) and the crucial strides we've made in supporting the HD community.

In January, the operational baton was handed over as Shaun Riley resigned, leading to my appointment as the Queensland Operations Manager for Huntingtons Queensland as well as the Community Programs & Services Executive for Huntington's Australia (HA) in March. Our immediate focus was ensuring the seamless continuity of existing services while ushering in a new era for Huntington's Australia.

Our dedicated team has been unwavering in its commitment to delivering critical services to the community, including:

- Facilitating referrals to government services, allied health professionals with HD expertise, and disability service providers.
- Assisting our community in accessing essential services such as the NDIS, DSP, and other crucial support programs.
- Providing non-clinical counselling services.
- Conducting training and educational programs for carers, support staff, and health professionals.
- Maintaining and supporting support groups, which have proven especially vital in the post-COVID-19 landscape.
- Extended our outreach efforts as we have established contacts in areas like Palm Island

With an eye toward expanding our services under Huntington's Australia, we successfully introduced Support Coordination in May as part of our NDIS Services, with valuable assistance from our counterparts in NSW/ACT.

As part of our collaborative efforts under Huntington's Australia, Lauren Ward relocated to Tasmania to provide HD Specialist services. Following Lauren's relocation, we welcomed Alyse Goodwin to the team in the same role.

Jen Lysiuk, who has been an invaluable part of our organisation for nearly 9 years, embraced the merger as an opportune moment to retire. We wish Jen a retirement filled with joy, travel, and flourishing gardens.

I am delighted to share that our service agreement with Queensland Health was successfully novated to Huntington's Australia, thanks to the unwavering support of the Queensland Health Department and its staff.

SERVICES REPORT

Our HD Advisers and support staff have worked hard to assist families impacted by Huntington's disease over the past 12 months.


In April HD Advisor Lauren was seconded to Huntington's Tasmania in the role of Senior HD Advisor and we welcomed Kelly Lambourne and Alyse Goodwin to our HD services team.

At a glance, Lauren, Tressa, Kelly and Alyse provided more than 310 hours of face-to-face support and many additional hours of non-clinical counselling and phone support to people impacted by Huntington's disease and their families this year.

Finding ways for people to stay connected was as always essential. Our HD services team clocked up more than 180 hours travel time to ensure they could see and assist as many people as possible.

SUPPORT GROUPS

Support groups remain a vital service provided by Huntingtons Queensland. It gives people in the HD community the chance to be heard, to listen to others' stories, learn, encourage, seek advice, and meet with people who understand what they are going through. Always present at the meetings is one of our HD Advisors who can advise and answer questions attendees might have.

Tressa, Lauren, Kelly & Alyse facilitated and attended over 40 support groups in Brisbane, Ipswich and around the State during visits to Cairns, Townsville, Mackay, Rockhampton, Gladstone, Bundaberg, Toowoomba, the Sunshine Coast and the Gold Coast.

Huntingtons Queensland continued to provide online support groups over Zoom including a dedicated carer's group for those who could not meet in person.

NATIONAL DISABILITY INSURANCE SCHEME (NDIS)

Huntingtons Queensland continues to work with many individuals to help them access the NDIS.

This year, as in previous years, our team has been committed to helping people to gather the information and evidence they require to support their NDIS applications, while advocating for their needs and wishes at NDIS planning meetings.

In collaboration with Huntington's NSW/ACT our clients were able for the first time to engage the services of an NDIS support coordinator employed within the Huntington's community. The support coordinator and HD advisors continue to collaborate to support our clients.

As access to the NDIS grows, there is a clear and growing need for appropriate education and training for support workers, whether they are supporting a person in their own home, or those living in other community or aged care settings. Likewise, we have identified an increase in the number of allied health workers seeking information and training about Huntington's disease, attributed to the NDIS's preference for people to live in the community wherever practicable.

INFORMATION, EDUCATION AND TRAINING

We continue to support clients who are also receiving assistance from other parties. This includes clients living in their own homes, in the community or in aged care. As many allied health or NDIS service providers have limited exposure or information about HD, our advisors often engage with client's providers to help them develop the skills to support the client in the best and most appropriate way.

Our information services are intended to help people make informed choices and access appropriate services and care in line with their individual circumstances.

Information and education sessions can be supplemented with follow-up advice and information by phone for service providers as required. The aim is to ensure that standards of care can be maintained over time, either as the person with HD's needs increase, or if there are changes to personnel.

CLINICAL CARE

Queensland's vast space and a shortage of health practitioners who have a good knowledge of Huntington's disease and how to support a person impacted by it will always present challenges to our community.

In line with educating NDIS and other service providers about supporting people who have HD, also important is our responsibility to educate and inform other health practitioners who provide care to people impacted by HD. A coordinated approach to an individual's needs is proven to optimise the quality of life of someone impacted by a life-limited disease.

Demand for access to secondary healthcare and clinical expertise, such as neuropsychiatry, is also high and trained clinicians are few and far apart.

Likewise, Queensland has very limited centralised services, where key clinicians are brought together in one place. For example, there is only one outpatients' clinic for Huntington's disease in Queensland, and that clinic is held only one day a month, in Brisbane.

Huntingtons Queensland is privileged to attend this monthly clinic, at the Royal Brisbane and Women's Hospital, and to offer our support to the highly skilled and hard-working clinicians who staff the service.

Pre-clinic, our team helps attendees to schedule, prepare for and get to their appointments where possible, and then stay with them at the clinic on the day. We also help to ensure that clinicians understand the person's concerns and questions during their clinical sessions, and then liaise with the person and other services post-clinic where required.

Waiting lists to see the clinic team stretch to months and, in many cases over 12 months. There has been a significant increase in Telehealth appointments with the clinical team. Telehealth is an increasingly important tool, especially for regional clients.

We believe there is a need for significant additional funding for outpatient clinics, both in Brisbane and elsewhere around the State, and for the employment of additional clinicians who have both a passion for and an understanding of Huntington's disease and other progressive neurological conditions.

There is a particular need for funded mental health support, including within the outpatients clinic, as families find themselves in crisis with very few avenues of finding help. Unfortunately, from our experience some mental health practitioners consider that Huntington's disease is not a mental health condition, despite people having very clear indications at times of being unwell but still not able to access mental health services in a timely manner.

ONE ON ONE SUPPORT

The support needed by clients is very individual and varied. Over the past financial year our advisors have set up referrals, accompanied people to medical appointments, provided support and advice to clients and family members who suspect a loved one has HD; encouraged people to legally record their wishes through wills, advanced care plans and other legally-binding documents, provided support to families who are struggling with parenting issues, and more.

In many instances case meetings involving complex supports for individuals impacted by HD are ongoing. These complexities often centre around a lack of appropriate or long-term accommodation, medication, complex mental health issues, domestic violence and complex behaviour support.

Financial stability can also be a challenge, therefore our advisors often help clients to complete paperwork and find supporting documentation for the Disability Support Pension, the NDIS, Centrelink and other avenues of financial support.

ADVOCACY

Huntingtons Queensland staff are passionate about supporting our clients through advocacy on a social, medical and political level.

A significant amount of our frontline team's time is spent supporting individuals one on one as they interact with the health, welfare and disability sectors.

On the wider issue of social and policy advocacy - We continue to work closely with the Public Guardian, NDIS, Queensland Health and other relevant agencies to ensure people with HD are supported and understood as their symptoms progress.

We were pleased to once again hold our annual forum thanks to the Alecca McKinless gift and the Rogers family. More than 80 people attended in November 2022 with presentations from Julie Stout, Huntingtons Queensland's Shaun Riley, Tina Knight and her Social Worker Deb Field, John Haberecht from Palliative Care Queensland, Occupational therapist Talisha Bryden, RBWH Senior Neurologist Associate Professor John O'Sullivan and HD family member Angelika Straker.

Our annual Running for Nan's HD fundraiser was not held in May due to the passing of 'Nan' at the age of 94 whom the event is named after. Kelly, granddaughter of 'Nan' decided to postpone the event until the second half of 2023. We send our deepest sympathy to Kelly and her family and thank her and husband Steve for their commitment and organisation of this wonderful community event.

In November we were able to facilitate an online training and information session with Occupational therapist Talisha from OpportunOTY. Participants paid to attend and over 30 occupational therapists from around the country attended.

PARTNERSHIPS

The Royal Brisbane and Women's Hospital HD Clinic continues to play a vital part in the journey of people impacted by the disease. Telehealth continues to be an important service provided by the clinic for those living regionally or too unwell to attend in person. Our HD advisors Lauren and Tressa were a mainstay of the monthly clinic – always there to support the staff and clients.

This year we continued our relationship with the Huntington's Disease Network of Australia (HDNA) and the Map-HD registry. In July we hosted an online information session with Audrey from HDNA who provided information about the registry and answered questions. The Map-HD registry aims to help HDNA understand who is affected by HD and to give them better access to clinical care and support services.

DIRECT MAIL APPEALS

Over the past year Huntingtons Queensland continued to rely heavily on the generosity of our donor community, who stepped up in a fantastic way to support our annual end of financial year and Christmas appeals.
